INFORMATIONS RELATIVES AU SUPPORT EN EUROS

SOGECAP considère que le(les) Support(s) en euros promeut(vent) notamment des caractéristiques environnementales et sociales.

Ainsi, au sein de l'actif global, SOGECAP :

- Analyse ses investissements¹ selon des critères Environnementaux, Sociaux et de Gouvernance (ESG) et met en place une approche « Best in class » consistant à sélectionner les entreprises les mieux notées dans leur secteur d'activité et à exclure les sociétés les plus mal notées.
- Met en œuvre des politiques de surveillance, d'exclusion ou sectorielles concernant notamment :
 - o les projets, les entreprises ou les secteurs qui font l'objet de critiques pour des raisons environnementales ou sociales (exemples : énergies fossiles, huile de palme, etc.),
 - o les entreprises du secteur de la défense impliquées dans les armes controversées,

Par ailleurs, SOGECAP évalue annuellement son portefeuille d'actifs selon les critères Environnementaux, Sociaux et de Gouvernance (ESG).
